The American Society of Agronomy is sponsoring a <u>FREE</u> upcoming webinar on managing Fusarium head blight of wheat. Fusarium head blight of wheat (also known as scab) is one of the most problematic diseases of wheat grown in the U.S. Not only can the disease cause direct losses to wheat yield and quality, but infected grains are also at risk for containing mycotoxins (e.g. deoxynivalenol [DON]).

The webinar has two parts, an hour each on Monday, February 11th and Monday, February 18th, and is free to participants because it's sponsored by the US Wheat & Barley Scab Initiative. Crop consultants, extension agents, and growers are encouraged to participate.

National Association of Wheat Growers: Weekly Update

NAWG CEO Responds to 2019 State of the Union Address

On Tuesday, President Donald Trump delivered his State of the Union Address. The theme of the speech was "Choosing Greatness" and focused on immigration, trade, infrastructure, healthcare, and national security.

NAWG CEO Chandler Goule provided the following statement in response:

"Wheat farmers are pleased to hear President Trump discuss the need to invest in America's infrastructure. With any infrastructure legislation, we hope the President and Congress prioritize the critical needs of rural infrastructure. This includes making improvements to transportation infrastructure, expanding access to broadband, and updating rural agricultural research facilities.

"As we consider our place in the world stage, let's make sure that we preserve smart trade deals that keep American wheat producers in a strong position. This includes remaining in NAFTA until the U.S.-Mexico-Canada trade agreement is in place and moving forward with new bi-lateral deals.

"We appreciate the President continuing to talk about the need to enforce our trade deals and commend the Administration's work to ensure countries like China are living up to its commitments. We recognize that China's trade policies are unfair and create unnecessary distortions that hurt U.S. farmers and other industries, which is why NAWG supports the two World Trade Organization (WTO) cases the U.S. has taken against China instead of tariffs.

"NAWG looks forward to continuing to work with the Administration and Congress on the implementation of the 2018 farm bill. The bill gives growers access to programs that allow them to produce high-quality crops while using fewer resources. Programs within the bill further the rural economy by creating new jobs, spur investment, and provide farmers with the tools they need to continue producing a safe and abundant food supply."

NAWG Participants in BNSF Annual Meeting

On February 6, 2018, NAWG VP of Policy and Communications Josh Tonsager and Past President Gordon Stoner attended the 2019 BNSF Ag Rail Business Council annual meeting. During the meeting, NAWG spoke on its priorities for 2019 focusing on our efforts to get the 2018 farm bill implemented, and NAWG's work to meet with Freshmen members and bring more awareness to the organization.

JOINT STATEMENT: Trade Mitigation Funds Will Benefit Export Market Development for U.S. Wheat Growers

U.S. Wheat Associates (USW) and the National Association of Wheat Growers (NAWG) are pleased that U.S. wheat growers now have the opportunity to increase efforts to expand export market access with USDA's Jan. 31 announcement awarding \$200 million to 57 organizations through the Agriculture Trade Promotion

Program (ATP). USW was awarded \$8.25 million, which will be distributed over the next three years. Administered by USDA's Foreign Agricultural Service (FAS), the ATP is one of three USDA programs within the Trump Administration's trade mitigation package—created to ease the effects of recent trade retaliation against U.S. farmers and exporters. The funds will support export market development programs led by U.S. trade associations, cooperatives and other industry-affiliated organizations.

NAWG Comments on Wetlands Rule

The U.S. Department of Agriculture (USDA) issued an interim rule for the Highly Erodible Land and Wetland Conservation Compliance provisions of the Food Security Act of 1985, as amended. This rulemaking clarifies how USDA delineates, determines, and certifies wetlands located on subject land in a manner sufficient for making determinations of ineligibility for certain USDA program benefits. The deadline to comment on the rule was Tuesday, February 5, 2019.

2019 AGRI Crop Research Grant Award

On Tuesday, February 5th, NAWG was notified that the Minnesota Department of Agriculture approved a 2019 AGRI Crop Research Grant award to the Minnesota Wheat Research & Promotion Council. The grant will fund the project, "Wheat Variety and Sourdough Product Analysis for Anti-Nutrient Levels Related to Digestibility". Congratulations to the Agricultural Utilization Research Institute! We look forward to reading the results of the project upon completion.

EPA and Army Announce Public Hearing on Proposed New "Water of the United States" Definition

The U.S. Environmental Protection Agency (EPA) and the Army Corps of Engineers have scheduled a public meeting Feb. 27-28 in Kansas City, Mo., on the administration's proposed "waters of the U.S." rule, which would narrow the jurisdiction of the Clean Water Act. An informational webcast is set for February 14th.

NWF Officially Opens 2019 National Wheat Yield Contest
